**NOTIFICATION**

It is hereby notified for general information that the Revised Rules & Regulations for Allotment of the University Quarter/Hostel duly notified by the University earlier vide Notification bearing Memo No. VUI/R/C0560/2019 dated 23.12.2019 is hereby partially amended.

**The existing provision at point no. 2 of the said Rules & Regulations :**

"an employee who is the owner of the house, in full or part, whether in his/her own name or in the name of other dependent members of /her family, within twenty five KMs radial distance from his/her place of posting are not eligible for allotment of University quarter/hostel."

Is hereby amended to the following effect:

**Amended Provision of Point No. 2 :**

" An employee who is the owner of the house, in full or part, whether in his/her own name or in the name of his/her parents, wife, husband, unmarried daughter, son or any other dependent members of his/her family within twenty (25) KMs radial distance from his/her place of posting are not eligible for allotment of University quarter/hostel."

Such amendment took place with the approval of the Vice-Chancellor of Vidyasagar University on 10.06.2022 and duly ratified by the Ninth Executive Council of Vidyasagar University in its Fourteenth (14th) meeting held on 29.06.2022. As decided by the Executive Council further, such provision of the point would be amended where applicable in the Revised Rules & Regulations for Allotment of the University Quarter/Hostel and other matters of the said Regulations will remain the same.

All stakeholders of the University are being informed accordingly and this amendment as passed by the Executive Council will come into force **with effect from 10.06.2022.**
