MEMORANDUM OF UNDERSTANDING UNDER INUP-i2i PROGRAM

BETWEEN

INDIAN INSTITUTE OF TECHNOLOGY KHARAGPUR

AND

VIDYASAGAR UNIVERSITY, MIDNAPORE

1. PREAMBLE

The Indian Nanoelectronics Users Program (INUP) was conceived and supported by MeitY, GoI and the Office of the PSA (OPSA) as an integral part of the initiative of establishing a Centre for Excellence in Nanoelectronics (CEN) initially at IISc and IIT Bombay in 2006. This program was later changed as INUP-Idea to Innovation (INUP-i2i) program and expanded to four other IITs (IIT Kharagpur, IIT Guwahati, IIT Madras, IIT Delhi). It was envisioned that the nanocenters, built by the teams of technical experts, should be national centres whose facilities are open to aspiring academic researchers from the country. These "open



national nanocenters" would inculcate a spirit of collaboration among researchers and raise the efficiency of operations by bringing in researchers from elsewhere in the country.


INDIAN INSTITUTE OF TECHNOLOGY KHARAGPUR (IIT KGP) and VIDYASAGAR UNIVERSITY, MIDNAPORE, hereinafter collectively referred to as 'the Parties' and individually as 'the Party' formally agree on a Memorandum of Understanding (MoU) as follows:

Indian Institute of Technology Kharagpur (IIT KGP) and the HEAD OF THE COLLABORATING INSTITUTE, for the purpose of furthering cooperation in education and R&D activities between these two institutions under the INUP-i2i program sponsored by MeitY, GoI, hereby affirm their intent to promote such academic collaborations and to participate in various academic endeavors.

2. OBJECTIVES:

This MoU envisages the fulfilling of the following objectives with the VIDYASAGAR UNIVERSITY, MIDNAPORE agreeing to the following:

- i. Conduct a minimum of 2 medium-term research projects at IIT KGP under INUP-i2i Program.
- ii. Avail internship for a minimum of two B. Tech/ M. Tech at IIT KGP under INUP-i2i Program.
- iii. Avail the usage of Nanofabrication Facility at School of Nano Science and Technology (SNST), IIT KGP by Ph.D./ Master's students with a minimum of three (03) users.
 - (a) **SHORT/ MEDIUM TERM projects at SNST, IIT KGP:** Under this program, VIDYASAGAR UNIVERSITY, MIDNAPORE PG/ PhD students/ faculty will visit IIT KGP for period of up to 3 / 24 months to execute short/medium term projects selected by IIT KGP under INUP-i2i program. The selected projects will be supported by IIT KGP as per the norms of INUP-i2i program.
 - (b) **IIT KGP Faculty support to INDIAN INSTITUTE OF TECHNOLOGY BHUBANESWAR:** IIT KGP may permit its faculty to visit VIDYASAGAR UNIVERSITY, MIDNAPORE for short durations to conduct awareness workshops/seminars under INUP-i2i.
 - (c) **Short term training programs:** Development and organization of short-term training/ workshop (Familiarization and hands-on training) by IIT KGP and enabling VIDYASAGAR UNIVERSITY, MIDNAPORE faculty / staff / students to take part in the above events under INUP-i2i at IIT KGP.
 - (d) **New areas of R&D:** Cooperation from IIT KGP for the development of new areas of R&D at VIDYASAGAR UNIVERSITY, MIDNAPORE.
 - (e) **Guidance in infrastructure development:** Extension of technical cooperation in the form of knowhow from IIT KGP for infrastructural development, management



and upgradation of library and teaching / research laboratories facilities at VIDYASAGAR UNIVERSITY, MIDNAPORE.

- (f) **Joint short-term programs and workshops:** To jointly organize short term continuation programs, seminars, conferences on topics of mutual interest and invite faculty members from both the institutions to participate.
- (g) **Use of Logo and name:** Each of the institutions will maintain their independent identity, logo symbol, image and make no other claims in their publicity material, media, websites, which is termed to be beyond the scope and nature of activities as incorporated in this memorandum. Each party will consult with and concur with the other party to use the names of the officials'/faculty members, and the logo for the activities under this MOU including dissemination of results and outcome under this MOU, in public.

3. COORDINATORS:

Both IIT KGP and VIDYASAGAR UNIVERSITY will identify coordinators whose responsibility will be to:

- (a) initiate action at their respective institutions to implement the provisions of this MoU
- (b) coordinate and monitor the activities initiated under this MoU
- (c) Undertake official visits to each other institutions to operate articles coming under this MoU.
- (d) National regulations and customs shall be mutually respected by all.

4. GENERAL PROVISIONS

- (a) The MoU shall remain in force for the duration of INUP-i2i from the date of signing the agreement unless either party gives a six-month notice of termination. This MoU may be extended further after review and by mutual written agreement.
 - (b) This MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expenses hereunder to the other Party until and unless definitive agreements have been negotiated and approved by the management levels of each Party.
5. **Financial Obligations:** There will be no financial obligations on both Parties under this agreement.
6. **Intellectual Property:** IIT KGP and VIDYASAGAR UNIVERSITY, MIDNAPORE agree to respect each other's right to intellectual PROPERTY. Further, all rights linked to ideas, inventions and patents generated during the MoU, if any, shall remain the common intellectual property of the parties. The Parties shall not pass on or give usage rights of such property to any third Party without the consent of the other Party. Any such research collaboration to be taken up during due course of time under the ambit of this present MoU shall be legitimized by signing an agreement.



7. **Dispute Settlement:** Any dispute, controversy, or claim arising out of or in relation to this MoU, including the validity, invalidity, breach or termination thereof, shall be settled by the parties amicably through mutual consultations and negotiations. proceedings shall be conducted through virtual mode or as may be directed by the Arbitration panel

E) This clause shall be taken into and be made part of any future agreements, contracts or MOU between the parties; and shall apply to all or any disputes that arise at any point in time between the parties.




8. **Liability:** The Parties shall have no liability to each hereunder.

9. **Legal Relationship:** This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create any legal relationship between the Parties. Details of specific cooperation will be determined on a case-by-case basis and by mutual agreement consistent with this memorandum of understanding. (MoU).

1. Purpose and Scope:

The purpose of this MOU is to establish a collaborative relationship between the Institute and the Company for the development and implementation of educational programs, research projects, and initiatives related to career development initiatives for better future prospects in the field of IT and ITES.

2. Areas of Collaboration:

3. Responsibilities:

4. Duration:

This MOU shall be effective as of the date first above written and shall remain in force for a period of three years, unless terminated earlier by mutual agreement of the parties.

5. Confidentiality:

Both parties agree to maintain the confidentiality of any proprietary information shared during the collaboration. The confidentiality would be maintained as per Intrucept's Group Information Security Policy and Standards adhering to Indian Data Protection Bill 2023, GDPR, NIST and ISO.

6. Governing Law:

This MOU shall be governed by and construed by the laws of Govt. of India.

7. Termination:

Either party may terminate this MOU upon providing 90 Daysdays' written notice to the other party.

8. Contract:


The renewal process for the Memorandum of Understanding (MOU) after the initial three-year period. Approximately Three months before the MOU's expiration, both parties (Vidyasagar University and Browse SkillTechnologies Private Ltd.- Community Driven Skill Exchange Platform and Intrucept Private Ltd.) should conduct a thorough review and assessment of the collaboration in renewing the same further.

Memorandum of Understanding between

Vidyasagar University, Midnapore

And

CSIR-Indian Institute of Chemical Technology, Hyderabad

In the spirit of intellectual cooperation scholarly exchange, and the development of national partnership with leading institutions, Vidyasagar University, Midnapore, West Bengal, (hereinafter referred to as **VU**) as the first part and CSIR-Indian Institute of Chemical Technology, Tarnaka, Uppal Road, Hyderabad-500007, Telangana State, a constituent unit of the Council of Scientific and Industrial Research (CSIR), a Society registered under Societies Registration Act (XXI of 1860), having its registered Office at Anusandhan Bhavan, Rafi Marg, New Delhi -110001, (hereinafter referred to as **CSIR-IICT**) of the second part.


Both the parties agree to establish a program of exchange and collaboration on related matters of mutual interest that may emerge over time in the field of Chemical, Biological and allied sciences.

1. The purposes of the cooperation are to promote cooperative research, training and extension activities to facilitate the exchange of ideas, the development of new knowledge/technology and to enhance high quality research and education acumen. The major thrust of the research on which the parties will cooperate is:

Isolation of plant secondary metabolites, their structural characterizations and study of their self-assembly properties in liquids, aqueous environment in VU; entrapment of drugs/drug like molecules, utilization in targeted delivery applications in cell culture and in animal models, structural modification of drug like molecules/secondary metabolites and evaluation for their potential biological use in established models in IICT.

2. VU and CSIR-IICT have agreed to:

- a. Initiate collaboration between faculty members and scientists in either Institute such that students/research scholars in either Institute get an opportunity to conduct research in advanced thrust areas in science and technology.
- b. Facilitate researchers (affiliated to either Institute) to collect data and conduct of experiments on various available equipment in either Institute on chargeable basis or concessional rates and as per the rules/regulation of the respective Institute.
- c. Facilitate access to library facilities such as subscribed journals and databases to collaborating researchers as per the rules/regulation of the respective Institute.
- d. Exchange faculty members/scientists/students and staff in collaborative research projects on areas of above-mentioned research expertise.
- e. Facilitate visit of students (post graduate in Chemistry and Chemical Technology as part of curriculum for executing project/dissertation/internships for short-term (up to 6 months) or long term (up to one year) training and research exposure as per guidelines of host institutes.
- f. Permit visit of faculty members/scientists on sabbatical to either Institute as per institute rules.
- g. Jointly publish research results generated out of collaborative research between scientists/faculty members involving both IICT and VU.
- h. Share knowledge by guest lectures/expert lecture (from either Institute) on the courses under curriculum without prejudice to the work/responsibilities of guest lecturer (Faculty/scientist) in their affiliated Institute.
- i. Draft and submit joint proposals in areas of mutual research interests to national and international funding agencies and industry partners.
- j. Apply for bilateral programmes on areas of expertise as mentioned above, as per the norms of respective institutes.
- k. Jointly conduct of societal relevant scientific programmes.



- l. Conduct Faculty Development Programmes (FDPs), National or International Conferences/Seminars/Symposium/Workshops etc., Skill development programs, certification courses, and training programs. Faculty members/Scientists may be resource persons in such events without prejudice to the work/responsibilities in their respective Institute.
 - m. Enter into separate agreements on case-to-case basis w.r.t joint projects taken up both Institutes within the tenure of this MoU.
 - n. Include other fields of study (not mentioned above) within the duration of this MoU by mutual written agreement between the two Institutes.
 - o. Include any other forth coming areas of mutual interests that are not included in the purview of this MoU through a separate agreement.
3. Prior to the initiation of any particular project or activity, the specific terms of cooperation and exchange for that project will be discussed and agreed upon in writing by the appropriate responsible representatives of both institutions.
4. Both parties understand that all financial arrangements for specific exchange activities must be mutually agreed upon and will depend on the availability of funds. In addition, the scope of the activities will be subject to funds available at the institutions for the type of collaboration undertaken and any financial assistance that may be obtained by either from external sources.

Both parties also agree to assist each other in correspondence with funding agencies as the case may be, to seek funds for the joint research programs or activities under this collaboration.
5. Either party may propose to the other specific individual research projects for collaboration. Such proposal may be made at any time and the parties will develop an agreement for each agreed-upon project **on case to case basis**. The protection and exploitation of any **intellectual property** arising out of a research project will be addressed in each individual project agreement early on and ongoingly.
6. Day to day implementation of this Agreement will be coordinated by **Professor Braja Gopal Bag, VU** and **Dr. Rajkumar Banerjee, Chief Scientist** and assisted by **Dr. Avijit Jana**, Senior Scientist at CSIR-Indian Institute of Chemical Technology, Hyderabad.
7. Each institution agrees to release and hold the other harmless from and against any claims, damages, liability or costs, to the extent such claims damages, liability or costs arise from the negligent or willful acts or omission of the other university or any of its agents or employees in connection with their respective performance under this MOU.
8. The parties agree that in the course of implementing this MOU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.
9. Amendments to this MOU may be made at any time after consultation and agreement between the two institutions. Any such amendment must be in writing and signed by both parties.
10. This MOU will remain in force for a period of **five years** from the date it is fully executed. The MOU can also be suitably modified, as agreed to by both the parties, to

reflect an increased scope, nature of engagement/activities including financial commitments, if any. Prior to the **expiration date**, the MOU may be reviewed for possible renewal for a further **three year period**. In addition, either party may terminate the MOU in advance of its normal **expiration** by providing the other with six months' prior written notice. In this case, persons already approved as exchange participants will be allowed to complete their exchange visits under the conditions specified at the time of their invitation to the host institution.

11. Confidentiality:

"During the tenure of the MoU and thereafter, both CSIR-IICT and VU undertake on their behalf and on behalf of their subcontractors/ employees / representatives / associates to maintain strict confidentiality and prevent disclosure thereof, of all the information and data exchanged /generated pertaining to work under this MoU for any purposes other than in accordance with this MOU".

12. FORCE MAJEURE:

If any party's performance of any of its obligations hereunder is delayed, prevented, restricted or interfered by any circumstances beyond the control of that party including but not limited to Acts of God, strikes, fire, accidents, flood, war, epidemics and Government directions, that party upon giving prompt notice to the other party, shall be excused from such performance to the extent of such prevention, restriction or interference; provided that the non-performing party shall use its reasonable efforts to avoid or remove such causes of non-performance and Shall continue performance hereunder whenever such causes are removed.

13. Arbitration:

Except as hereinbefore provided, any dispute arising out of this MOU, the same shall be referred to the arbitration of two arbitrators one to be appointed by each party to the dispute, and in case of difference of opinion between them to an umpire appointed by the said two arbitrators before entering on the reference, and the decision of such arbitrators or umpire as the case may be shall be final and binding on both. The venue of arbitration shall be such place as may be fixed by such arbitrators or umpire, and the arbitration proceedings shall take place under the Indian Arbitration Act, 1940 as modified in 1996.






Memorandum of Understanding between
Vidyasagar University, Midnapore
And
Indian Institute of Packaging, Kolkata Centre

In the spirit of intellectual cooperation scholarly exchange, and the development of national partnership with leading institutions, Vidyasagar University, Midnapore, West Bengal, (hereinafter referred to as VU) as the first part and Indian Institute of Packaging, Kolkata Centre, (hereafter referred to as IIP-Kolkata) of the second part.

Both the parties agree to establish a program of exchange and collaboration on related matters of mutual interest that may emerge over time in the areas of academic exchange, certificates courses, workshop, student exchange, faculty exchange.

1. The purposes of the cooperation are to promote cooperation in incubation, certificate courses, skill development, joint workshop, exchanges of students, scholars and faculty members.
2. VU and IIP Kolkata have agreed to:
 - a. Initiate collaboration between faculty members and scientists in either Institute such that students/research scholars in either Institute get an opportunity to conduct research in advanced thrust areas in science and technology.
 - b. Facilitate researchers (affiliated to either Institute) to collect data and conduct of experiments on various available equipment in either Institute on chargeable basis or concessional rates and as per the rules/regulation of the respective Institute.
 - c. Facilitate access to library facilities such as subscribed journals and databases to collaborating researchers as per the rules/regulation of the respective Institute.
 - d. Exchange faculty members/scientists/students and staff in collaborative research projects on areas of above-mentioned research expertise.
 - e. Facilitate visit of students (graduate and post-graduate students in different subjects as part of curriculum for executing project/ dissertation/internships for short-term (up to 6 months) or long term (up to one year) training and research exposure as per guidelines of host institutes.
 - f. Permit visit of faculty members/scientists on sabbatical to either Institute as per institute rules.
 - g. Jointly publish research results generated out of collaborative research between scientists/faculty members involving both IIP and VU.
 - h. Share knowledge by guest lectures/expert lecture (from either Institute) on the courses under curriculum without prejudice to the work/responsibilities of guest lecturer (Faculty/scientist) in their affiliated Institute.
 - i. Draft and submit joint proposals in areas of mutual academic interests to national and international funding agencies and industry partners.
 - j. Apply for bilateral programmes on areas of expertise as mentioned above, as per the norms of respective institutes.
 - k. Jointly conduct of societal relevant scientific programmes.
 - l. Conduct Faculty Development Programmes (FDPs), National or International Conferences/Seminars/Symposium/Workshops etc., Skill development programs, certification courses, and training programs. Faculty members/Scientists may be resource persons in such events without prejudice to the work/responsibilities in their respective Institute.
 - m. Enter into separate agreements on case-to-case basis w.r.t joint projects taken up both Institutes within the tenure of this MoU.
 - n. Include other fields of study (not mentioned above) within the duration of this MoU by mutual written agreement between the two Institutes.
 - o. Include any other forth coming areas of mutual interests that are not included in the purview of this MoU through a separate agreement.
3. Prior to the initiation of any particular project or activity, the specific terms of cooperation and exchange for that project will be discussed and agreed upon in writing by the appropriate responsible representatives of both institutions.
4. Both parties understand that all financial arrangements for specific exchange activities must be mutually agreed upon and will depend on the availability of funds. In addition, the



scope of the activities will be subject to funds available at the institutions for the type of collaboration undertaken and any financial assistance that may be obtained by either from external sources.

Both parties also agree to assist each other in correspondence with funding agencies as the case may be, to seek funds for the joint research programs or activities under this collaboration.

5. Either party may propose to the other specific individual research projects for collaboration. Such proposal may be made at any time and the parties will develop an agreement for each agreed-upon project on case to case basis. The protection and exploitation of any intellectual property arising out of a research project will be addressed in each individual project agreement early on and ongoingly.
6. Day to day implementation of this Agreement will be coordinated by Professor Braja Gopal Bag, Coordinator Incubation Centre, VU and Dr. Bidhan Das, Deputy Director and Regional Officer, IIP Kolkata.
7. Each institution agrees to release and hold the other harmless from and against any claims, damages, liability or costs, to the extent such claims damages, liability or costs arise from the negligent or willful acts or omission of the other university or any of its agents or employees in connection with their respective performance under this MOU.
8. The parties agree that in the course of implementing this MOU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.
9. Amendments to this MOU may be made at any time after consultation and agreement between the two institutions. Any such amendment must be in writing and signed by both parties.
10. This MOU will remain in force for a period of **five years** from the date it is fully executed. The MOU can also be suitably modified, as agreed to by both the parties, to reflect an increased scope, nature of engagement/activities including financial commitments, if any. Prior to the **expiration date**, the MOU may be reviewed for possible renewal for a further **five year** period. In this case, persons already approved as exchange participants will be allowed to complete their exchange visits under the conditions specified at the time of their invitation to the host institution.

11. Confidentiality:

"During the tenure of the MoU and thereafter, both IIP Kolkata and VU Midnapore undertake on their behalf and on behalf of their subcontractors/ employees / representatives / associates to maintain strict confidentiality and prevent disclosure thereof. of all the information and data exchanged /generated pertaining to work under this MoU for any purposes other than in accordance with this MOU".

12. FORCE MAJEURE:

If any party's performance of any of its obligations hereunder is delayed, prevented, restricted or interfered by any circumstances beyond the control of that party including but not limited to Acts of God, strikes, fire, accidents, flood, war, epidemics and Government directions, that party upon giving prompt notice to the other party, shall be excused from



such performance to the extent of such prevention, restriction or interference; provided that the non-performing party shall use its reasonable efforts to avoid or remove such causes of non-performance and Shall continue performance hereunder whenever such causes are removed.

13. Arbitration:





Kalasalingam Academy of Research and Education, represented by its Vice Chancellor **Dr S Narayanan**, having its campus at Anand Nagar, Krishnankoil, Virudhunagar District, Tamil Nadu (which term shall, unless repugnant to the context be deemed to include its heirs, executors, administrators, and assigns) of the Second Part, called hereinafter as the **Second Party**.



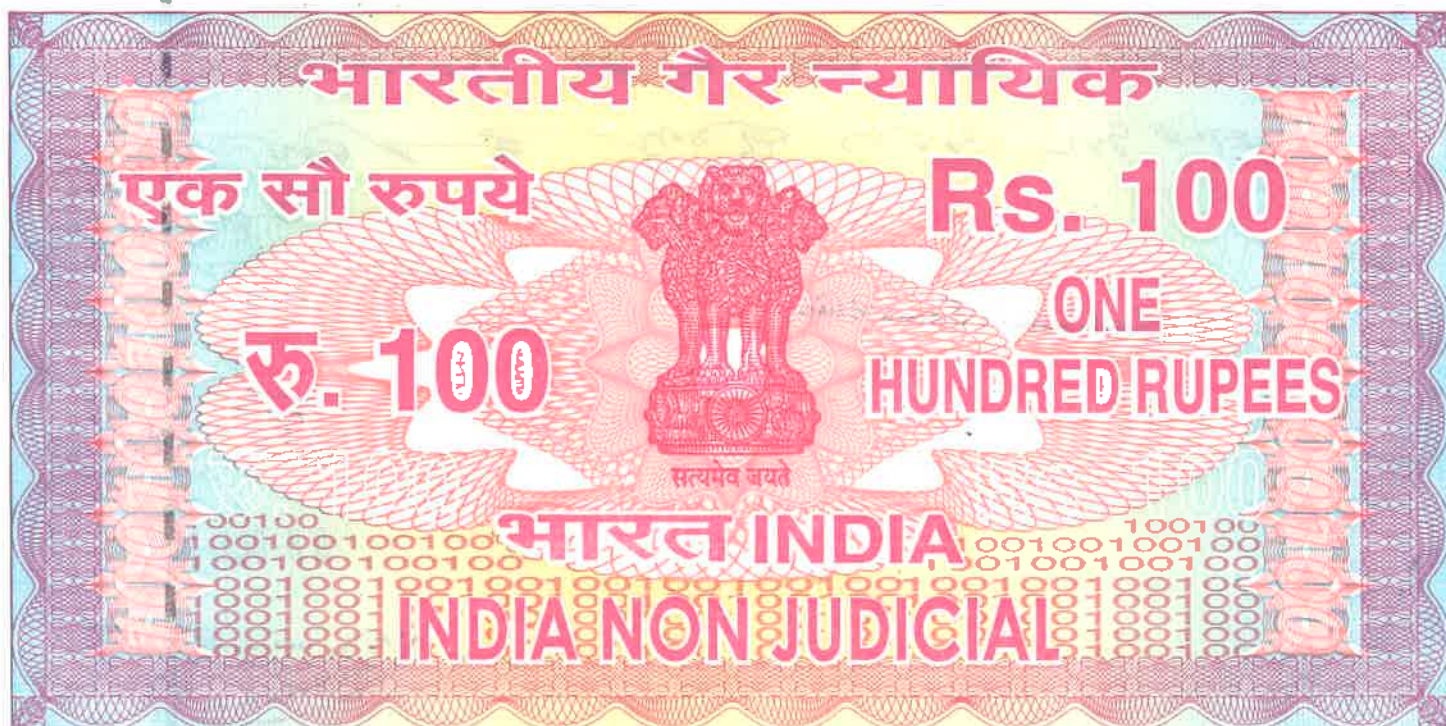

Maharaja Sriram Chandra Bhanja Deo University (Which expression unless excluded or is repugnant to the context shall include its successors and assignees), on the First Part and to be represented by the appropriate authority, Vidyasagar University (Which expression unless excluded or is repugnant to the context shall include its successors and assignees) on the other part.

That Maharaja Sriram Chandra Bhanja Deo University (MSCB University), formerly North Orissa University (NOU) was established by the Government of Orissa, under the Section 32 of the Odisha University Act, 1989 (Act 5 of 1989), vide notification No. 880 dated 13th July 1998.

It was carved out of the Utkal University and became operational since 1999 at Takatpur (98.84 acres) of Baripada in the Mayurbhanj District of Odisha as an affiliating university. The University is recognized by the University Grants Commission under Sections 2(f) and 12(B) of UGC Act, 1956 with effect from 15th February 2000 and 21st June 2006, respectively. The territorial jurisdiction of the university extends over Mayurbhanj district of northern Odisha, thickly populated with tribal communities. The MSCB University's jurisdiction covers 56 colleges of Mayurbhanj.

MSCB University is recognized by Bar Council of India, DEC, IGNOU, NCTE and included in the list of Association of Indian Universities and Association of Commonwealth Universities.

Vidyasagar University after establishing through Legislative Act in the State Assembly in the year 1989 and started its academic journey from the year 1996 with opening of four different courses. Vidyasagar University is functioning with a mission to bring about transformative changes through socio-economic, educational and cultural development in

the region called Jangal Mahal where it is located sharing borders with the neighboring states of Odisha and Jharkhand. In order to fulfill its commitment to the people of the region, the university intends to foster collaborative endeavors by forging synergistic engagements with the academic institutions across the states. A true progress and rounded development can only be achieved if the university becomes successful in establishing Memorandum of Understanding (MoU) with other universities and in materializing the plan of actions as per the MoU. Before working out a full-length draft of the MoU, Vidyasagar University expresses its intention to identify the prospective areas of collaboration. Each referred to individually as a "Party" and together as the "Parties" henceforth.

Objective: The MoU drawn up and agreed upon to establish academic and allied cooperation between Maharaja Sriram Chandra Bhanja Deo University and Vidyasagar University.

ARTICLE 1: PURPOSE

The purpose of this MoU is to enable cooperation between Maharaja Sriram Chandra Bhanja Deo University and Vidyasagar University and to strengthen academic, research collaboration, students' exchange and other activities as found suitable upon mutual consent between Maharaja Sriram Chandra Bhanja Deo University and Vidyasagar University.

ARTICLE 2: SCOPE/AREAS OF COOPERATION

The MoU relates to proposed links between the Maharaja Sriram Chandra Bhanja Deo University and Vidyasagar University.

Both the parties propose to participate and co-operate in mutual discussions and joint activities with regard to the following:

Establishment of an Academic and Research partnership that provides opportunities for both the Universities to carry out and publish joint research papers, propose and administer joint research projects and develop joint patents.

OBJECTIVES

1. Bringing positive changes in tribal life culture and local migrants

Odisha and West Bengal share many a common feature so far as their tribal peoples are concerned. Tribal communities namely Santal, Bhumij, Ho, Lodha, Savar, Birhor, Kharia, Munda, Oraon live in both the states. In fact, Odisha and West Bengal are two major states where a large number of Scheduled Tribes (STs) including PVTGs have concentrated. Socio-linguistically and genetically they also present similarities. The region where Vidyasagar University is located has comparatively the highest concentration of tribal people in the State. The University is consistently working towards making positive changes which the people consider best for them keeping their identity and culture protected. We can exchange our expertise in materializing more tangible benefits for the tribal people, local

migrants in order to preserve their traditional culture, indigenous knowledge and threatened languages.

2. Development of Folk art and craft

Both the states have a treasure of folk arts, crafts and expressive art forms with a great deal of commonness. World famous Chhou dance has different stylistic expressions prevalent in Odisha and West Bengal. The folk painting (patachitra) is common to both the states which differ only by their regional styles. The crafts of doll making, wooden works, stone carvings, pottery and metal craft (dokra) are met with in these states. However, there are artistic traditions unique to the States, which will be points of special attention to the scholars and interested people. It may open up possibilities of economic development and tourism in the region.

3. Exploration of environment and ecology for a sustainable growth

The adjoining areas of Odisha and West Bengal bear considerably similar topography having diverse ecosystem like forest, coast, wetlands and wastelands which leads to similarities of environmental conditions and ecology. The life and culture, floral and faunal diversities, and adaptive features of living organisms can only be fully explored if effort is made across the borders. The environmental impacts of development are not confined in the territorial jurisdiction. The Anthropocene demands a more holistic understanding of the environment and of the living creatures therein. Therefore, concerted efforts of both the institutions are required in this regard. More emphatically, focus be given on the issues like i. Vegetation cover and health, ii. Ecosystem services assessment including EIA and iii. Biodiversity and traditional knowledge inventorizing, utilizing both ground truth survey and modern tools of Remote Sensing & GIS.

Several departments like Anthropology, Botany, Zoology, Wildlife & Biodiversity Conservation, Biotechnology, Chemistry, Santali, Remote Sensing and GIS, Centre for Adivasi Studies and Museum, Centre for Women Studies, Center for Similipal Studies and Centre for Environmental Studies, an interdisciplinary approach to address the problems of environment can effectively take part in undertaking research based studies on the aforesaid subjects effectively in collaboration with the faculties and researchers of both the Universities.

RESPONSIBILITIES

Both the parties do hereby agree to undertake the followings:

- Joint research, including publications and other appropriate activities, between staff and/or students from each institution.
- Facilitate the exchange of staff, students and researchers for the purpose of teaching, study, research and extension activities.
- Provide administrative support for growth of academic and research endeavours.

- Provide mentor advice and support to the other party for growth of its academic and research activities.
- Identify areas of possible mutual academic and research interest.
- Identify potential research opportunities and initiatives to take forward the activities.
- Enable the dissemination of information and the sharing of experiences among staff and students.

Both parties also agree to encourage the following activities, in particular, to promote academic cooperation in the following areas:

- a) Institutional exchanges between students and staff;
- b) Organization of joint seminars, symposia, conferences, short courses, Summer School and meetings on academic and research issues;
- c) Exchange of information pertaining to developments in teaching, pedagogy, student development and research activities and;
- d) Cooperation in any other areas as agreed to by both the Parties from time to time.

ARTICLE 3: DURATION, TERMINATION AND AMENDMENT

1. This MoU will be effective from the date of signing by both parties for a period of 3 years, and may be subject to extensions by mutual consent in writing.
2. Either party may terminate this MoU by giving six (6) months advance notice in writing.
3. The provisions of this MoU may be amended at any time with the mutual consent of the parties in writing.
4. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the two parties.
5. Any legal issue arising out of this MoU may be amicably settled at a court at Bhubaneswar, Odisha, India.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

- 4.1 Intellectual Property Rights (IPR) generated during the Research, under this MoU shall be shared in accordance with the mutual understanding of the parties at the point of filing of the patent. General rules however could be following:

4.1.1. Joint Intellectual Property ("Joint IP"): the Parties shall agree that the application for patent registration and/or any other rights that can be registered shall be filed in joint names.

4.1.2. Maharaja Sriram Chandra Bhanja Deo University shall file, process, maintain and extend patents or other appropriate rights of registration concerning Intellectual Property Rights that have been developed jointly and shall keep Vidyasagar University informed about the status of all such actions. Similarly, Vidyasagar University shall file, process, maintain and extend patents or other appropriate rights of registration concerning such joint Intellectual Property Rights and shall keep the Maharaja Sriram Chandra Bhanja Deo University, informed about the status of all such actions.

Both the parties shall execute necessary documents and provide assistance in order to protect interest of both the Parties under this clause.

4.1.3. Joint patents would be owned jointly and both parties would have equal ownership in the same.

4.1.4. Neither Party shall withdraw the application for any patent nor any other applicable right filed pursuant to Section 4.1.3.

4.1.5. Both Parties shall have the right to use the Joint IPR, for their own use only. This shall be carried out with the mutual consent of both parties.

4.1.6. Parties shall each take the consent of the other before sublicensing the Joint IPR, and pay the other a royalty depending on the valuation of their research contribution on mutually agreed price.

4.2 No Party shall acquire any ownership interest in any other Party's Background rights while performing joint research. Respective parties shall remain owners of their respective Background Rights.

ARTICLE 5: CONFIDENTIALITY

5.1 During the validity of this MoU and three [3] years thereafter, Maharaja Sriram Chandra Bhanja Deo University undertakes on its behalf and on behalf of its students/employees/ associates/ representatives and Vidyasagar University undertakes on behalf of its students/ employees/ associates/ representatives to maintain strict confidentiality and prevent disclosure thereof, of all the Confidential Information and data exchanged/ generated pertaining to Academic and Research work under this MoU for any purpose other than in accordance with the MoU.

5.2 Notwithstanding anything stated in this MoU, Maharaja Sriram Chandra Bhanja Deo University, its faculty members/ associates involved and Vidyasagar University's Faculty/ associates/ representatives shall not in any event disclose Confidential Information related to Intellectual Property to any third party.

5.3 The obligations set forth in this clause shall survive any termination or expiration of this MoU for a period of five years.

ARTICLE 6: SPECIAL PROVISIONS

6.1 Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon on a case-to-case basis in separate Memoranda of Agreements (MoA).

6.2 Each party will take approval from the other party in writing to use the latter's name and logo for the activities here under on a case-to- case basis.

6.3 Both parties here shall do their utmost to ensure the smooth and efficient implementation of the mentioned programs.

6.4 The two parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.

ARTICLE 7: FINANCIAL IMPLICATIONS

7.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.

7.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding.

SCOPE OF MOU

ACADEMIC INTERACTION

Both NIPER-KOLKATA and Vidyasagar University, Midnapore, shall encourage interactions between the faculty members and students of both the organizations through the following arrangements:

- a) Collaboration on joint projects funded by external funding agencies / industry or by the Institutes (NIPER-Kolkata and Vidyasagar University, Midnapore)
- b) Organization of joint conferences and seminars;
- c) Expert lectures from Vidyasagar University, Midnapore and vice-versa;
- d) Guidance of student projects, internships of students in academic programs of mutual interest at NIPER-KOLKATA and Vidyasagar University, Midnapore.

SHARING OF FACILITIES

The sharing of exact facilities will be decided on the basis of requirements for each project and on mutual agreement.

- a) NIPER-KOLKATA and Vidyasagar University, Midnapore shall make provisions to share their respective R&D facilities in order to promote academic and research interaction.
- b) Both the institutes shall provide access to their library facilities to scientists, members of faculty and students as per the prevailing rules and norms in the respective institutes.

EFFECTIVE DATE AND DURATION OF MOU

- a) This MOU shall be effective from the date of signature by the competent authorities at both ends.
- b) The duration of the MOU shall be for a period of 5 years from the effective date.
- c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than one month by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a program or are involved in any joint project or internships under the MOU.



- d) Any clause or article of the MOU may be modified or amended by mutual agreement of NIPER-KOLKATA and Vidyasagar University, Midnapore.

COORDINATORS

Dr. Sharada Prasanna Swain from NIPER-Kolkata and Dr. Surojit Das from Vidyasagar University, Midnapore shall act as coordinators for successful implementation of the programmes under the MoU.

IPR AND PUBLICATION RIGHTS

Rights regarding publications, patents, royalty, ownership of software/design/product developed etc. under the scope of this MOU, shall be decided by the two parties by mutual consent.

CONFIDENTIALITY

During the tenure of the MOU both NIPER-KOLKATA and Vidyasagar University, Midnapore will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.

Both NIPER-KOLKATA and Vidyasagar University, Midnapore shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.

Further both NIPER-KOLKATA and Vidyasagar University, Midnapore shall put in place adequate and reasonable measures to keep and store, and secure confidential information secure so as to prevent any unauthorized use.

CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to PARTIES collectively or individually, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbally, or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party



before such disclosure or during the discussions. However confidential information shall not include any data or information which:

- (a) is or becomes publicly available through no fault of the receiving party,
- (b) is already in the rightful possession of the receiving party prior to its receipt of such data or information;
- (c) is independently developed by the receiving party without reference to the confidential information of the disclosing party
- (d) is rightfully obtained by the receiving party from a third party or is in the public domain
- (e) is disclosed with the written consent of the party whose information it is, or
- (f) is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party.

AMENDMENTS



Any amendment and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.

RESOLUTION OF DISPUTES

The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be resolved subject to jurisdiction of civil courts at Kolkata or Midnapore.

MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (hereinafter called as the 'MOU') is made on 20th Day of February 2024 at Midnapore, West Bengal.

BETWEEN

Vidyasagar University, India represented by its Vice-Chancellor, Prof. Dr. Susanta Kumar Chakraborty having its campus at Vidyasagar University Rd, Rangamati, Midnapore, West Bengal – 721102, India hereafter referred to as the **First Party**.

AND

Patuakhali Science and Technology University, Bangladesh, represented by its Vice-Chancellor Prof. Dr. Swadesh Chandra Samanta, located at Dumki, Patuakhali-8602 (which term shall, unless repugnant to the context be deemed to include its heirs, executors, administrators and assigns) of the Second Part, called hereinafter as Patuakhali Science and Technology University, Bangladesh as **Second Party**.

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- a) **First Party** is a UGC recognized State University in West Bengal and the Vidyasagar University Act, 1981' has been passed by the West Bengal State Legislative Assembly, and the same has been published in Kolkata Gazette. The campus is replete with a variety of facilities, viz. State-of-the-art labs, well-stocked library, Wi-Fi, seminar halls, modern auditorium, technology enabled classrooms, hostels, guest house, other conveniences on campus including ATM, photo copy centre, canteens, playground, gym and more in order to render a wholesome learning experience for our students. Vidyasagar University beliefs

in delivering quality education through interactive learning and extra-curricular activities, for a moral and academic enrichment in creating future scholars and professionals. It is a University with over 4000+ students, more than 160 academic members, offering specialized PG degree and PhD degree programmes in 14 subjects in science faculty and 13 subjects in arts and commerce faculty.

- b) Patuakhali Science and Technology University, Bangladesh, the Second Party is a Public University operating under the University Grants Commission of Bangladesh. The Patuakhali Science and Technology University was developed at the private initiative of the local people through the establishment of a higher secondary institute in 1972 as a private college. It was then turned to Patuakhali Agricultural College under the affiliation of Bangladesh Agricultural University (BAU), Mymensingh in 1979 with the objective of producing agricultural graduates offering the BScAg (Hons) degree. The college was nationalized on 01 February 1985 and was placed under the administrative control of the Bangladesh Agricultural Research Institute (BARI), Ministry of Agricultural together with BAU affiliation. The university was inaugurated on 08 July 2000 by the then Honorable Prime Minister, Government of the Peoples Republic of Bangladesh, Her Excellency Sheikh Hasina and started its academic activities on 26 February 2002 under the Patuakhali Science and Technology University Act 2001. The main campus of the PSTU is located at about 20 km north from the district town of Patuakhali and about 38 km south from the divisional city of Barishal. The outer campus is situated at Babuganj under Barishal district. The campus is affluent with a variety of facilities, viz. laboratories, well-equipped library, Wi-Fi coverage, modern auditorium, technology enabled classrooms, hostels, guest house, other conveniences on campus including ATM, photocopy centre, canteens, playground, gymnasium, health care centre and more in order to render a wholesome learning experience for the students. Despite having comparatively small campus, along with the academic activities, the students of the university have ample opportunities to perform different sports and cultural activities. The PSTU has been offering undergraduate and postgraduate programmes in Agriculture, Computer Science & Engineering, Business Administration & Management, Animal Science, Veterinary Medicine, Fisheries, Environmental Science and Disaster Management, Nutrition and Food Science, and Law and Land Administration. It is a University with over 4,146 students, more than 253 academic members, offering specialized UG, PG degree and PhD degree programmes in 08 (eight) faculties. Patuakhali Science and Technology University beliefs in delivering quality education through interactive learning and extra-curricular activities, for a moral and academic enrichment in creating future scholars and professionals. We believe our success lies in our

passion for teaching and learning and our commitment to our students. Our challenge for the future is to build on this strong base to establish ourselves firmly among the leading universities.

- c) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- d) The Parties intent to cooperate and focus their efforts on cooperation within the overlapping areas of Skill Based Training, Education and Research.
- e) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the University Campus and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of both Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of both the Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of

Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MoU

- 2.1 The budding graduates from the University could play a key role in technological up-gradation, Research and innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design and academic publications:** Both the Parties will share valuable inputs to each other in teaching / training methodology, curriculum design. Both the Parties agreed to exchange experiences, study materials, academic publications and reports to each other so that the students and faculty members of both the institutions will be benefited.
- 2.3 **Joint Educational Activities:** Both the parties agreed with the educational activities (including but not limited to conferences, symposia, workshops, training, lectures, study tour) on subjects of mutual interest jointly.
- 2.4 **Student, Staff and Faculty Exchange:** Both the institutions shall seek to promote to the exchange of faculty, students, and PhD Scholars to the mutual benefit of both institutions.
- 2.5 **Research and Development:** Both Parties have agreed to carry out the joint research activities and consultancy work in fields of mutual interests.
- 2.6 **Skill Development Programs:** Both the Party agreed to train the students and university personnel of other Party on the emerging technologies in order to bridge the skill gap and make them professionally ready.
- 2.7 **Guest Lectures:** Both the Party will extend the necessary support to deliver guest lectures to the students of the other Party on the technology trends and in house requirements.
- 2.8 **Faculty Development Programs:** Both the Party agreed to train the Faculties of other Party for imparting training.

- 2.9 There is no financial commitment on the part of the **Vidyasagar University**, the First Party and the **Patuakhali Science and Technology University**, the Second Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3: INTELLECTUAL PROPERTY

- 3.1 Intellectual properties shall be governed by the IPR policies of both respective institutions. Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4: VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Midnapore, West Bengal, India.

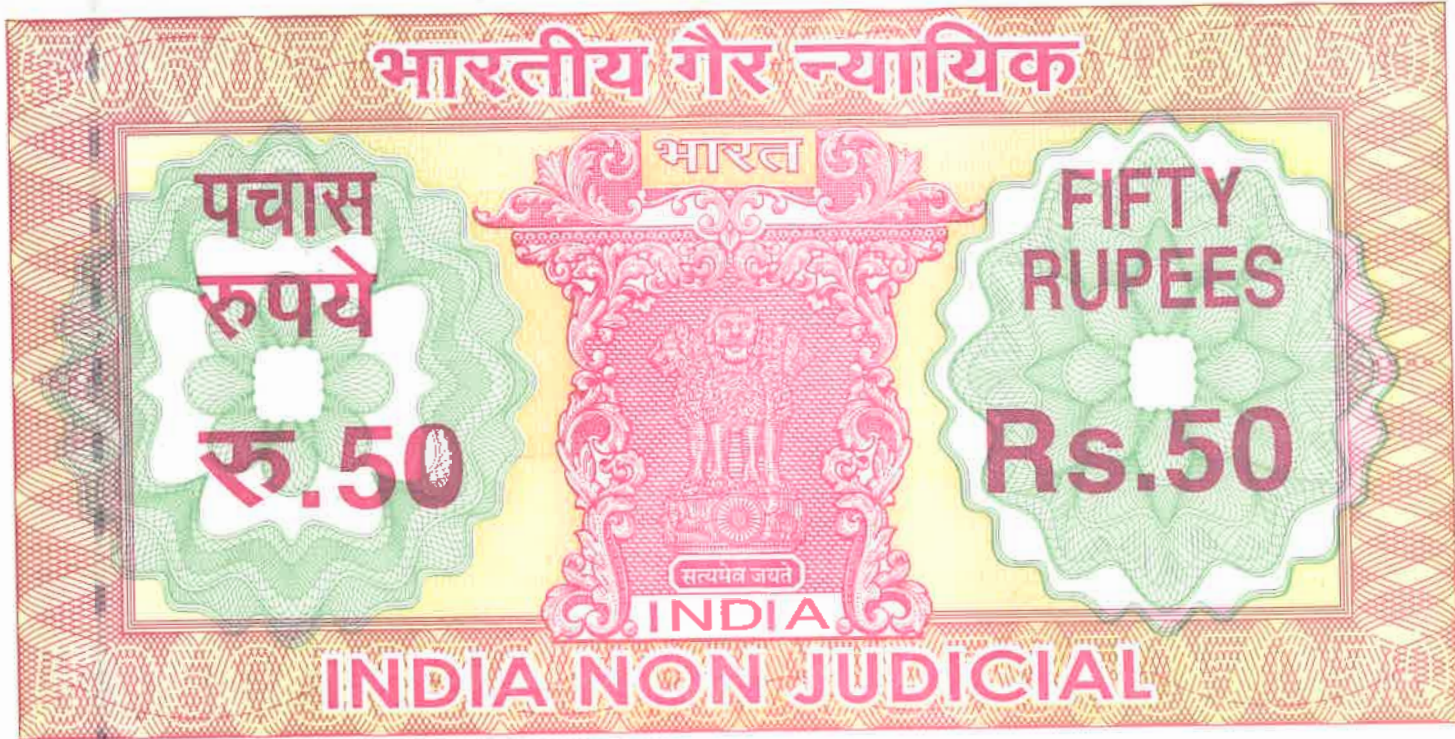

NOW THEREFORE THIS MOU WITNESSETH AS FOLLOWS

1. Collaborative Research:-

- (i) It is agreed by the parties to initiate steps -
 - a) to encourage collaborative research projects by individual scholars or faculty members or among related departments and to establish continuing interactions. The financial aspects and other terms and conditions of such joint research projects will be finalized on mutual discussion and consent of the parties hereto;
 - b) to organize and participate in conferences, symposia, courses, workshops, exhibitions and other joint meetings of mutual interest;
 - c) to initiate joint training/education programs to raise competency in Applied Mathematics;
 - d) to undertake funded research projects jointly and share the funds allotted thereto according to such terms and conditions prescribed by funding agencies.
- (ii) **Exchange of academic materials:-**
Each organization will exchange relevant materials pertaining to research, scientific advancements and library, on a regular basis as approved by both organizations on mutual discussion. Exchange of reference materials in libraries for research purpose will be encouraged.
- (iii) **Exchange of Academic / Technical staff :-**
Both the parties agree to depute suitable academic/research students to participate in Workshops/Seminars/ Conferences conducted in each institution and present papers and deliver lectures.
- (iv) **Visiting Research Fellows :-**
Either organization may nominate one or more of its faculty/research students to visit the other organization for the purpose of advanced study or research, subject to the approval of the host organization.

2. Terms & Conditions of collaboration: -

- (i) The terms and conditions for each specific collaborative activity to be undertaken under this MoU, shall be mutually discussed and agreed upon in writing, by exchange of letters, between the parties to this MoU.
- (ii) Any such letters or agreements entered into, as outlined above, shall form part and parcel of this MoU.
- (iii) This MoU is not a contract creating any legal or financial commitments between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial academic exchange programs.



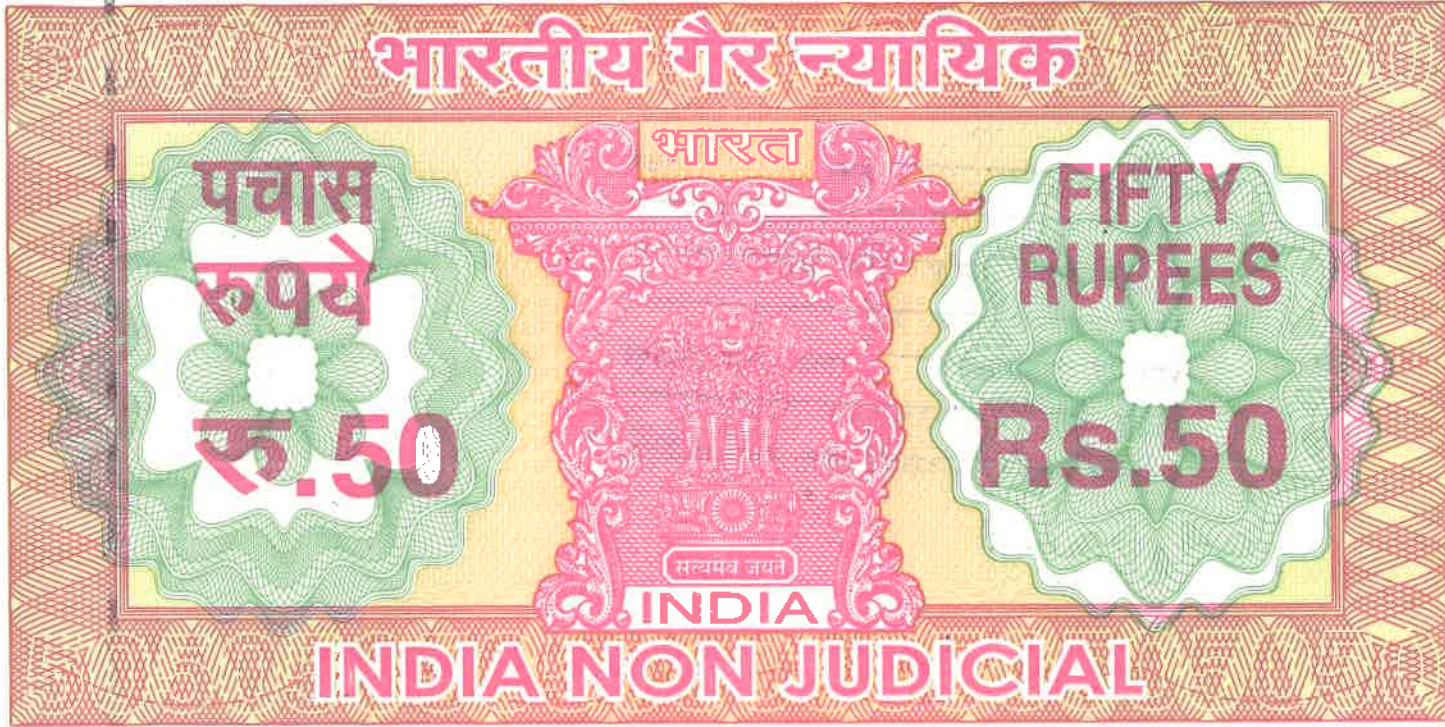

MEMORANDUM OF UNDERSTANDING

FOR UNDERTAKING RESEARCH AND TEACHING COLLABORATION

BETWEEN

ZOOLOGICAL SURVEY OF INDIA, KOLKATA

AND

VIDYASAGAR UNIVERSITY, MIDNAPORE

This Memorandum of Understanding (this 'MoU') is made and entered into on this 30th of June 2024 (effective date) by and between ZOOLOGICAL SURVEY OF INDIA, Kolkata and VIDYASAGAR UNIVERSITY, Midnapore.

The Zoological Survey of India (ZSI), Kolkata and the Vidyasagar University (VU), Midnapore, agree that for encouragement and development of cooperation and exchange in areas of mutual academic and research interest, it is desirable to enhance research and educational processes at both the institutes and to strengthen mutual understanding between their respective staff, research scholars and students. The Zoological Survey of India, represented by the **Director, ZSI, Kolkata** and **Vidyasagar University, Midnapore**, represented by the **Vice Chancellor, VU** hereby, enter into an agreement for scientific and academic cooperation and have set forth the following Articles of Mutual Agreement:

Article 1.

The bonafide students and research scholars of both Institutions will have access to research facilities and logistics at Vidyasagar University, Midnapore, and Zoological Survey of India. Scientists/Faculty members of VU and ZSI may mutually use and share research and education facilities. Both ends shall together try to develop and maintain state-of-the-art facilities.

Article 2.

The exchange programmes (involving scholars and/or scientific staff) and/or research projects, are not intended to be legally binding documents. They are meant to describe the nature and suggest the guidelines of the programme or project. Nothing, therefore, shall diminish the full autonomy of either university or institution, nor will any constraint be imposed by either upon the other carrying out the agreement.

Article 3.

The activities of both the Institutions will be two-fold: off-campus in the coastal region and on-campus at main campus, as elaborated below: -

Under **off-campus activities**, attempts are to be made in gathering, processing and dissemination of meteorological and ecological information for the well-being of the local people i.e. fishermen, whereas the **on-campus activities** will include collaborative research on: -

- i. Faunal diversity of the terrestrial and marine ecosystems of the region
- ii. Taxonomy & molecular systematics
- iii. Application of Remote Sensing & GIS technology to understand the trend of ecological changes

For collaborative research the Scientists/Faculty members of VU and ZSI may seek research funding jointly from public and private funding agencies of national and/or international repute.

Article 4.

The scientists of ZSI conducting research shall be recognised as Supervisors/Joint supervisors for Doctoral Programmes from **Centre for Environmental Studies, Centre for Life Sciences, Department of Zoology** and or any related Biological Science departments, as the case deemed by VU and as per the provisions outlined in the UGC regulations notified time to time. The ZSI will also be permitted to conduct Ph.D. programme jointly as a **Sister Organization/Research Centre** under VU. In the research papers published from the thesis work of the candidate registered with VU, the affiliation of the concerned student should appear as VU and ZSI.

Article 5.

Scientists/Faculty members of VU and ZSI may mutually conduct/host workshops, seminars, conferences for which certificates will be issued by VU to all candidates after successful completion of workshops, seminars, conferences (cosigned by VU and ZSI).

Article 6.

To carry out and fulfil the goals of this agreement both universities/institutes shall designate program coordinator(s) to develop and coordinate the specific programs and projects agreed upon.

Article 7.

Under this agreement, there will be no financial liability on the VU or on the ZSI from either side.

Article 8.

The 'MoU' will remain effective for five (5) years. Research and educational programs would be conducted as and when required either at Vidyasagar University, Midnapore or at ZSI, Kolkata or both places combinedly based on mutual consent. The 'MoU' may be extended or revised after every 5 years on mutual discussion between the two Institutes viz. VU and ZSI. If either organization wishes to terminate the MoU at the end of the five years period or in between the period of five years, it must notify the other organization not less than six months prior to the expiry of the MoU. The event of termination will not affect participants from completing their activities at the host institution already initiated or ongoing unless otherwise mutually agreed. Modifications to MoU will be made by mutual consent and any

amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two institutions.

Article 9.

In the event of any unforeseen issues or matters not covered herein or any controversy, dispute or difference arising out of or in connection with this MoU, the same shall be resolved amicably by both the organizations. This MoU and further agreements will in all respect be governed by and construed in accordance with the laws of Govt. of India. This MoU shall be signed in counterpart. Each counterpart will constitute an original document and these counterparts taken together, shall constitute one and the same MoU.
