

## **Vidyasagar University**

### **Policy for Research promotion**

The University encourages and promotes high quality research of the faculty members and the research students. To ensure this, the University provides grants to encourage faculties to attend national/international conferences bearing the cost of travel and registration fees. The University encourages the faculties to apply for research projects to funding agencies through a screening process. It also provides various overhead and logistical support after a faculty secures research grants from outside agencies. The University also provides the Personal Research Grants (PRG) to every faculty member to meet a portion of their research work, outside grants from outside agencies. It also provides grants to the academic departments to publish their research journals. Further to this, the University will provide a Start Up grants for the new faculties, who will be selected on the basis of merit.

On the other hand, to maintain the quality of research work of PhD students, the University will install an efficient plagiarism checking software, accepted by competent authorities. The plagiarism-checking will be strictly mandatory before a candidate submits his/her PhD dissertation.
