- 4) Committee has also suggested to reconstitute the Anti Ragging Committee &Anti Ragging Squad for this new session, and asked the DSW to do the needful & placed to authority for final approval.
- 5) Committee already informed/ suggested to admission cell to collect the filled up Anti Ragging affidavit form at the time of admission from all the newly admitted first year students.

- (a) As the name of the applicant is not mentioned in the letter, it is difficult to identify the victim, as per the Department none of the students reported this thing to HOD, However on the basis of primary investigation tomorrow department along with other members will talk to the all individual students to counsel them so that he/she feels safe and knows that authorities are with them.
- (b) As advised by the Registrar , the entire thing is discussed and informed to the police authority accordingly.
- (c) As the accused student's are from Zoology under CCAE 1st semester, committee requested the Director CCAE to talk to all HOD/Coordinator (under CCAE) to talk to the 1st semester students individually and counsel them as per the norms.

(d) As there were no other matters for discussion, the meeting ended with a vote of thanks and regards to all the members present.
